

**Conditions : -**

- 1) As per the grant -in-aid Act to the colleges any further grants the government will not be entertained. The course is considered as permently unaided.
- 2) Following University Acts for colleges is mandatory.

9) College management should not hold marks cards or any such documents of students for six months or till University approves admissions for further action.

10) College Management should not torture if student requests for Transfer Certificate. Only remaining fees of concerned semester is collected. No collection of any other fees is entertained.

11) No collection of capitation fees in any kind.

12) Maintaining roster in admission process is mandatory.
